Treasurer's Report: August Financials- No financial reports, Cindy had bank statements from all of the accounts for the board to review. PRAT money and CDs were discussed Bauman and Associates have been contacted to do an audit of the books for the VOS they have not given us a cost. Dan made a motion to sign the contact with conditions that it would on exceed \$5000.00 without acknowledgment seconded by Jerry motion carried.

Park Committee Report: YTD park income is \$18,779.00 approximately \$10,000.00 less than last year due to flooding. Committee is working on updating the web-site and tree removal, Closing of the park is October 15th with a worker bee on October 19th Matt made a motion to accept the Park report seconded by Dennis motion carried.

Cemetery Committee Report: Lynn reported that mowing has been started on the new area, invoice was handed to Cindy for reimbursement for tree cutting and Title work. The cemetery is in the Town of Stockholm the Village would like cost-sharing with the Town of Stockholm for cemetery expenses. Dan made a motion to approve the report seconded by Jerry motion carried.
