Well has a small leak between the well and tank. Repair next spring.

Pay box was cut again, looking into replace lock and move the pay box

Revine has accumulated drift wood that could cause flooding

Canoe/kayak rack request by Mary Logue. Would like her to come up with plan for location, maintenance and general management

Storage building

Zoning Administrator's Report- Vacation rentals. Will have to update the conditional use permits.

NEW BUSINESS:

- 1. Action in regard to ongoing Village request for transitional speed zones on highway 35-No word from the state. Will file another request. Harley will keep everyone updated.
- 2. Discussion of \$5050.00 estimate by Ivan Boras for masonry repair- John has put in a lot of work into this project.
 - Dukan (member of the general public) spoke to the board about a paint that is used on

historical building that allows the concrete to breath. John made a motion to have Ivan Boras repair and stabilize/tuckpoint the Village Hall 2nd by Jerry motion carried.

- 3. Discussion of up to \$3000.00 for small shed-Dave spoke to the board members about the cost of the material for the skid to place the building on. Green treat 4x4's (\$104) and 2x10's (\$173) for an 8x10 shed.
 - Jerry made a motion to spend up to \$3000.00 for an 8x10 shed 2nd by John motion carried. The park committee will discuss the plans at the October meeting.
- 4. Discussion of a \$200-\$300 expenditure for Pepin County survey-Harley was in communication with Maria Nelson, Pepin County zoning and the village attorney to review the land exchange. Pepin county needs a certified survey map. Pepin County surveyor can do that, at a cost of \$100.00 per hour, it should take about two hours. Dennis made a motion for an expenditure of \$300.00 for a Certified Survey Map for the land exchange 2nd by John motion carried. Harley will be in contact with Pepin County Zoning.
- 5. Progress on Park Project- ADA grant work was completed. Pam Horlitz is working on plans for a large fire pit.
- 6. Winter Solstice event- char spoke to the board members about the 3rd weekend in December. The sculpture burning is scheduled around 5:45 behind Sandy's after there will be a procession to the park for a drum performance and bonfire.
- 7. ADA Park Grant updates-Lines will have to be painted on the black top for ADA.
- 8. Citizen Concerns-Carol Hinderlie accident on the shoulder of the road. Harley will talk to the Hinderlie's, about the accident and where it happen.

Dennis spoke to the board about the new improvements at the park. Members of the community would like to pay tribute to Heidi for her hard work, like a street name or a bench in her honor. The park committee will consider this and get back to the board.
